How child-friendly is the Government of Swaziland?

The African Report on Child Wellbeing provides an insight into the wellbeing of children in Africa and assesses the extent to which governments meet their obligations, through a ground-breaking **Child-friendliness Index** – developed by The African Child Policy Forum (ACPF).

The Government of Swaziland was found to be one of the least child-friendly governments in Africa

The Government of Swaziland ranked 45th in the Child-friendliness Index, out of the 52 African governments covered in the assessment. This was mainly for two reasons: first, as a result of the Government of Swaziland not putting in place appropriate legal provisions to protect children against abuse and exploitation, its fair commitment to achieving favourable wellbeing outcomes for children. It did however perform well in its commitment in allocating adequate share of the national budget to provide for the basic needs of children.

How well does the Government of Swaziland perform in protecting its children?

A number of indicators have been used to assess governments' performance in protecting children against abuse and exploitation (see report for the detail).

The ranking puts the Government of Swaziland 51st in respect of legal protection of children, indicating its very low performance (out of 52) in laying appropriate legal and policy foundations for the protection of children. Swaziland has ratified only three of the eight relevant child rights treaties (see Table 1).

Swaziland ranked 51st for its effort to put in place an appropriate legal and policy framework for children.

The Government of Swaziland performed fairly in respect of indicators relating to national plan of action for survival, protection and development of children and a government body for coordinating the national strategy for children. It also has a policy for free primary education and a national law on sexual exploitation. Swaziland does not have national laws on child trafficking or harmful traditional practices, nor a juvenile justice system. Corporal punishment is not prohibited in the home, school or penal system (see Table 2).

How does the Government of Swaziland perform in providing for children?

Provision for basic needs of children is measured based on two elements: budgetary commitment and child-related outcomes achieved. All the indicators used for budgetary commitment and child-related outcomes were combined to yield governments' performance score for provision of basic services for children (see Figure 1).

Swaziland ranked **14th** in the combined index for provision of basic services for children

The other set of indicators refer to the outcomes achieved for children. They measure governments' performances in terms of objective results achieved in services accessed and results reflected on children themselves. Table 3, below, summarises the indicators and the data used for this particular sub-dimension for Swaziland.

Figure 1 Budgetary expenditure on selected sectors, Swaziland

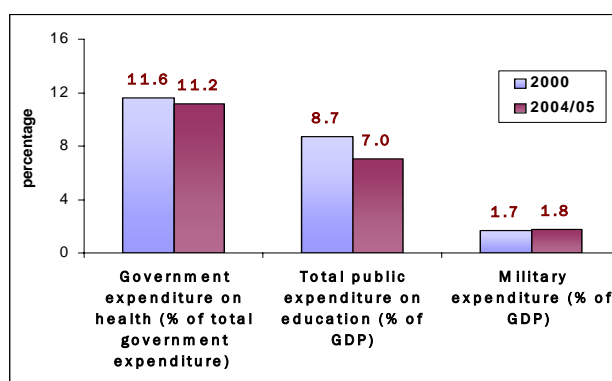
